How to Apply

- Annual membership is €30 per family for 1 year. Or €50 for 2 years. In return, you will receive one
 photo membership card, that may be used to explain to others that your child has additional needs
 due to Autism or allow you to avail of discounts to some venues that provide offers for those with
 additional needs.
- 2. If you require additional cards of the same child, these are charged at an extra €5 per child.
- 3. Payment can be made by the following options:
 - a. Cheque/Bank Draft/Postal Order made payable to "Snowflakes Autism Support".
 - b. Bank Transfer: Please email <u>membership@snowflakes.ie</u> for the details.
 - c. PayPal: Payment can be made via <u>https://www.paypal.me/snowflakesautism/</u>
- 4. A passport sized photograph of your Snowflake should accompany every application and renewal.
 - a. Snowflakes understands that it is not always easy to get a good passport photo of our children, so please submit the best that you have. We will endeavour to crop to size.
 - b. For renewals, we can reuse the photo we have on file if you select for us to do so. However, we do encourage new photo's to be used if possible.
- 5. Please send the completed form (page 1 only), membership fee (if not paying by Bank transfer or PayPal), a recent passport sized photograph of your child to:

Member Rules

- 1. All membership is at the discretion of the membership committee.
- 2. Snowflakes reserves the right to cancel memberships at their discretion.
- 3. Membership fee is €30 or €50 per family. This will provide one ID Card of each qualifying child. Additional cards for your child/children are charged at an extra €5 each.
- 4. Membership is for 12 or 24 months from the date the membership application is processed.
- 5. Membership expiry date will be the final date of the expiry month.
- 6. Length of membership is calculated from the 1st day of the month of joining Snowflakes.
- 7. If membership is not renewed within 3 months of the renewal date, membership service is reset to zero.
